---

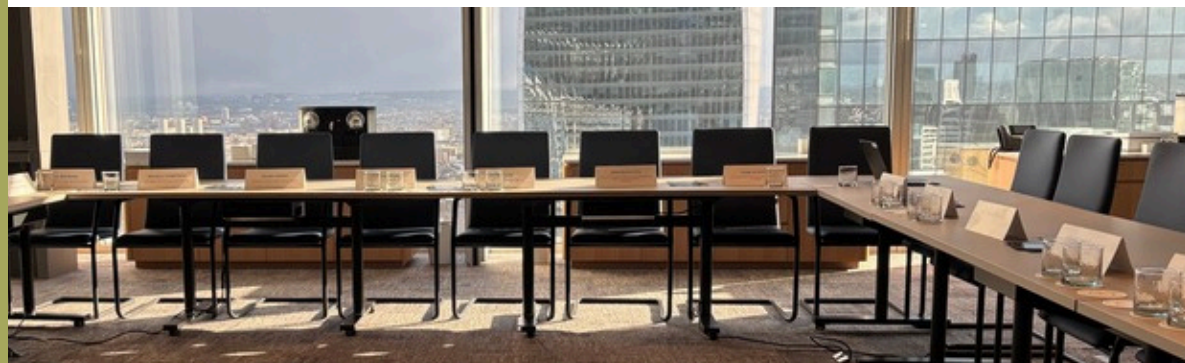
The global corporate governance landscape is undergoing significant change. Investor stewardship, new regulation, geopolitical competition, industrial policy, and technological change are reshaping the environment in which companies operate.

Boards face growing expectations from investors, evolving shareholder rights and voting infrastructure, sustainability regulation, and competition with state-backed global rivals. Governments are also revisiting industrial policy, strategic ownership, and economic sovereignty.

The ECGI Patrons Council brings together three groups that rarely meet in a structured setting:

- corporate leaders responsible for governance and strategy
- institutional investors shaping stewardship and voting practices
- policymakers and academic experts developing regulatory frameworks.

The Council provides a forum for examining governance challenges and the policy and market developments shaping companies and capital markets.

Planned discussion topics include investor stewardship and voting trends, shareholder engagement and voting infrastructure, proxy advisers, capital market dynamics, industrial policy, economic sovereignty, strategic ownership structures, governance challenges in strategic industries, institutional investor expectations, board composition, and broader regulatory and policy developments affecting companies and investors.
